- 2. Approved meeting agenda, previous two JMM meeting minutes, 2022 annual report.
- 3. Youth ministry vision (refer to Adriel's slides)
 - 1. Pastor Adriel shared the four main focuses for youth ministry, including: diversity, empowering the group, building strong relationships, and creating long-term vision.

- 5. Financial update and 2023 budget (refer to Cedric's slides)
 - 1. If expenses are >\$5000 over budget, the request will require JMM approval;
 - 1. If the expense is <\$5000, requires CB approval
 - 2. Certain budget items reflect the rise in inflation; other increases are due to increased ministry needs
 - 3. We have a significant surplus because every leader is careful with their expenditures; we have historically spent less than the budgeted amount.
 - 4. Our church would be in a deficit situation if we had spent money according to the approved budget.
 - 5. Also, over 1/3 of our annual offering is received in Dec. While in Dec we may see a surplus, but we need this money to pay for expenses during the first eleven months of the year.
 - 6. 2023-24 budget approved
- 6. Pastoral Search Committee update (refer to Claire's slides)
 - 1. 2022 we had 3 vacancies
 - 1. Senior pastor
 - 1. no applications received
 - 2. position continues to be posted in 2023
 - 2. Assistance director of children ministry
 - 1. three applications received
 - 2. hired Claire in Oct, 2022
 - 3. Cantonese associate/assistant pastors (two)
 - 1. four applications received

- 7. Mission Committee update (refer to slides)

 - 4. Updated list of organizations sponsored by our church, and future special projects

- 9. Facilities Committee update (refer to slide)
 - 1. North building roof was last repaired in 2002, and its 20-year warranty expired last year.
 - 2. There was a water leak in Oct, 2022. It now requires shingle replacement and structural reinforcement.
 - 1. Multiple quotes will be requested and reviewed.
 - 2. Project details will be presented in May, 2023 JMM.
 - 3. South building roof was last repaired in 2008. It was inspected last year with no signs of repairs required.
