Church Leadership Nomination Procedure Guidelines

A) Positions to be elected in the Joint Membership Meeting:

- 1) Church Board (CB) Directors
- 2) Ministry Management Team (MMT) Deacons
- 3) Cantonese Ministry & Operations Team (CMOT) Deacons
- 4) English Ministry & Operations Team (EMOT) Deacons
- 5) Mandarin Ministry & Operations Team (MMOT) Deacons
- 6) Up to 3 Elders

B) Three nomination tracks:

- 1) Nomination Committee
- 2) Church Board, MMT & MOT
- 3) Two active members may nominate an active voting member

Procedure to nominate an active voting member of SCCEFC

- 1) Pick up from the Church Office the Nomination Package comprising of (a) Nomination Form (Parts A & B), p.1-2; (b) Guidelines for Nomination Procedures, p.3-4; (c) Essential Qualifications & Scriptural Reference for church leaders, p.5-9; and (d) Extracts of the By-laws governing nomination procedures and roles/responsibilities of different positions, p.10-11.
- 2) Pray for the nominee(s) you have in mind.
- 3) Invite the nominee(s) to consider (with a specific leadership position) in prayer.
- 4) If the nominee agrees to proceed, the two nominators will complete Part A of the Nomination Form which is duly signed and dated, and then hand the whole Nomination Package to the nominee for completion of Part B of the form with signature & date.
- 5) The nominator will submit the completed and signed Nomination Form (Parts A & B) to the Nomination Committee on or before November 24, 2023.
- 6) The Nomination Committee will interview the nominee and complete the evaluation process.
- 7) A written profile of the recommended candidates will be provided to the membership by January 14, 2024.
- 8) An election will be held on January 28, 2024

Notes:

- 1) Nominee is a person who is selected or nominated for a certain position. Candidate is a person who has completed the nomination process and recommended to be elected.
- 2) To protect the privacy of all nominees, only the list of eligible candidates will be disclosed in the JMM
- 3) Active members are defined in the church bylaws.
- 4) There is no limit to the number of candidates for any particular leadership position. The successful candidates will be those that receive the highest number of votes during the election.
- 5) In the case of any conflict between the Chinese translation of the by-laws quoted in the nomination form and the by-laws in English, the approved and most up-to-date version of the by-laws in the original English language shall prevail.

Scriptural Reference for Church Leaders

Exodus 18:21-22

21 But select capable men from all the people—men who fear God, trustworthy men who hate dishonest gain—and appoint them as officials over thousands, hundreds, fifties and tens. 22 Have them serve as judges for the people at all times, but have them bring every difficult case to you; the simple cases they can decide themselves. That will make your load lighter, because they will share it with you.

- Select from the people.

- Honest and trustworthy.
- Can identify serious cases and able to solve them collectively.

1 Timothy 3:1-13

3 Here is a trustworthy saying: Whoever aspires to be an overseer desires a noble task. 2 Now the overseer is to be above reproach, faithful to his wife, temperate, self-controlled, respectable, hospitable, able to teach, 3 not given to drunkenness, not violent but gentle, not quarrelsome, not a lover of money. 4 He must manage his own family well and see that his children obey him, and he must do so in a manner worthy of full[a] respect. 5 (If anyone does not know how to manage his own family, how can he take care of God's church?) 6 He must not be a recent convert, or he may become conceited and fall under the same judgment as the devil. 7 He must also have a good reputation with outsiders, so that he will not fall into disgrace and into the devil's trap.8 In the same way, deacons[b] are to be worthy of respect, sincere, not indulging in much wine, and not pursuing dishonest gain. 9 They must keep hold of the deep truths of the faith with a clear conscience. 10 They must first be tested; and then if there is nothing against them, let them serve as deacons.11 In the same way, the women[c] are to be worthy of respect, not malicious talkers but temperate and trustworthy in everything.12 A deacon must be faithful to his wife and must manage his children and his household well. 13 Those who have served well gain an excellent standing and great assurance in their faith in Christ Jesus.

1 Timothy 4:16

16 Watch your life and doctrine closely. Persevere in them, because if you do, you will save both yourself and your hearers.

loves what is good, who is self-controlled, upright, holy and disciplined. 9 He must hold firmly to the trustworthy message as it has been taught, so that he can encourage others by sound doctrine and refute those who oppose it.

1 Peter 5: 1-4

1 To the elders among you, I appeal as a fellow elder and a witness of Christ's sufferings who also will share in the glory to be revealed: 2 Be shepherds of God's flock that is under your care, watching over them—not because you must, but because you are willing, as God wants you to be; not pursuing dishonest gain, but eager to serve; 3 not lording it over those entrusted to you, but being examples to the flock. 4 And when the Chief Shepherd appears, you will receive the crown of glory that will never fade away.

28 Keep watch over yourselves and all the flock of which the Holy Spirit has made you overseers. Be shepherds of the church of God,[a] which he bought with his own blood.
